Policy Statement

We aim to provide a comfortable and safe indoor environment that allows flexibility and access to a variety of quiet, active, group and individual activities. We will ensure that only the number of children that can comfortably fit into the building space will be enrolled. We aim to provide a safe and secure outdoor environment where children have access to a variety of activities, in which they are encouraged to participate. We will provide an outdoor space which promotes investigation and respect for the natural environment.

Procedure

Indoor Environment

The service's indoor environments will be smoke free. No Smoking notices will prominently be displayed.

The service will only enrol the number of children which can comfortably fit into the available indoor building spaces and in accordance with the Education and Care Services National Regulations. The service is currently approved for 160 places.

The service works closely with the school with respect to availability of indoor space. Currently, the main indoor spaces available to children include the BASC building, the school hall and the school library. Where children are indoors for long periods due to weather conditions, special activities will be planned and additional indoor spaces sought to disperse the group, such as classrooms.

Separate areas in the indoor environment will be provided for:

- Parents to sign their children in/out of the Centre
- Staff to answer phones and maintain daily records
- Staff and parents to talk in privacy and confidence
- Children to store their bags and belongings
- Storage of equipment, food, dangerous materials, and family records
- Preparation of food and drinks
- Kitchen and other refuse
- Cleaning of equipment
- Male and female toilet, hand basins and hand drying facilities
- Creative and other activities
- Large and small group activities
- Display of children's activities and work
- Quiet space for children to retreat to, relax or lie down if unwell

The indoor spaces will be inspected daily for any obstacles or dangerous items through a daily risk assessment. Any hazards will be noted on the WHS Risk Assessment form and reported to the responsible person on duty.

The indoor areas will be set up to allow children to participate in a variety of activities with easy access to equipment and resources.

Easy access to areas should be maintained by making clear and easily definable passageways and walkways through the building. Markings on the floor indicate clearways.

Staff will ensure that children properly store their bags and that bags and other items are not thrown into walkways or play areas.

All items obstructing areas are to be removed and placed in the correct storage areas.

Access for families with disabilities will be maintained ensuring all necessary requirements are considered in the building environment. Areas must be set up to ensure that proper supervision can be maintained at all times.

Indoor areas will be well ventilated, include adequate natural light, and be maintained at a temperature which ensures the safety and comfort of all, where possible. All indoor areas have access to a First Aid Kit.

Outdoor Environment

The outdoor environment will be smoke free. No smoking notices will be prominently displayed.

The outdoor area is easily accessible to the staff and children.

Adequate shade via trees and coverings will be maintained. As far as possible, activities will be set up in shaded areas.

Various climatic conditions are taken into account when using the outdoor space. Undercover areas will be made available to all children when using the outdoor environment in cases of wet weather and extreme heat. Staff and children will be required to demonstrate appropriate sun protection in compliance with the Sun Protection Policy.

Children have safe, easy access to toileting facilities as well as access to fresh water.

The outdoor area is comprised of both fixed and moveable equipment. Equipment and outdoor resources are kept in a separate storage shed and staff ensure equipment is made available to children during allocated outdoor play time. The outdoor space will be set up in a variety of ways to encourage participation. Areas will be made available where children can play in large or small groups or by themselves.

The outdoor environment will promote enjoyment of the natural environment and provide opportunities for unique play and learning as well as offer children opportunities for active, noisy and messy play on a large scale. Children will be encouraged to engage with the natural environment (see Environmental Sustainability Policy).

The outdoor space will be inspected by staff daily for any obstacles or dangerous items, using a Daily Hazard Identification Checklist. Any dangerous items will be disposed of in a safe and careful manner, prior to the children playing in the area. The service will work with the school to manage any risks in the available outdoor areas, where necessary.

Supervision will be properly maintained. Children are only to play in the areas that are clearly visible to the staff, and where proper child/staff ratios are maintained. Clear boundaries are set and enforced during each session. When it is necessary to go outside the boundaries or line of supervision, a staff member will accompany children.

Portable Fist Aid Kits will be accessible to staff in areas currently in use. Children must seek permission from a staff member and be supervised by that staff member when transitioning between areas.

Use of other outdoor venues will be considered where access to the area is safe, adequate supervision can be maintained, the area is considered of value to the children's physical development and personal comfort, and where adequate staff/child ratios can be maintained both indoors and outdoors.
