### **Child Safe Standards**

1	Child safety is embedded in organisational leadership, governance and culture.

### **Policy Statement**

We respect the right of individual parents to choose whether to immunise or not to immunise their children. However, children who are not immunised will be excluded for the period of an outbreak that is a vaccine-preventable disease. Proof of immunisation will be sought at the enrolment stage and recorded in the enrolment form.

### **Procedure**

Parents must provide the service with a copy of their Immunisation History Statement upon enrolment as evidence of child's immunisation status. This information will be recorded in the enrolment form.

#### West Ryde BASC Inc. Policies and Procedure



Children who are not immunised can still be enrolled to the service if they are enrolled in formal schooling. However, in the event of an outbreak of a vaccine-preventable disease at the service or school attended by children at the service, children not immunised will be required to stay at home for the duration of the outbreak, for their own protection.

The Public Health Unit will be notified if any child contracts a vaccine-preventable disease (see Illness and Infectious Diseases Policy).

Payment of fees will be required for children excluded during an outbreak of a vaccine-preventable disease, unless other arrangements discussed and agreed to by the Management Committee have been made.

#### **Immunisation for Staff**

All staff should also maintain their immunity to common childhood diseases through immunisation.

Staff will be encouraged to undergo immunisation for Hepatitis B if they are not already immunised. It is also recommended that all adults receive a booster dose of tetanus and diphtheria vaccine every 10 years.
