### **Policy Statement**

We aim to provide an environment that is safe, that is free of risk to the health and wellbeing of our children, staff and parents. We will ensure that all activities undertaken are not hazardous and that all hazardous materials are handled and stored in accordance with legislative obligations.

#### **Procedure**

Hazardous machinery, chemicals and activities which are likely to cause potential danger to our children, staff and others in the Centre will not be used or undertaken while the Centre is in operation.

Should any pests or vermin be identified then action should be taken to rid the Centre of the problem by initially using non-chemical methods such as physical removal, maintaining a clean environment, and use of any non-chemical products (see Pest Control Policy).

#### West Ryde BASC Inc. Policies and Procedures



Low irritant, environmentally friendly sprays will be used minimally and only with adequate ventilation, and preferably not in the presence of children. Aerosol cans, such as spray paints etc. used for specific activities, will only be used outside in a well-ventilated area.

All staff will be made aware on initial orientation to the Centre of any potentially dangerous products, which may pose a danger to the children, where these dangerous products are stored and how these should be handled.

All potentially dangerous products, such as cleaning materials, disinfectants, tools, toiletries, first aid supplies/equipment and medication, will be stored in accordance with regulations.

All staff are responsible for ensuring the dangerous goods remain secure and are not inadvertently accessible to the children.

Cleaning and hazardous products will be stored separately from food to mitigate any potential contamination.

Staff should always read the label before using any cleaning materials, sprays or chemicals and familiarise themselves with the appropriate first aid measures.

Education about dangerous products and their storage can be used to enhance both children's and parent's awareness of the topic. Activities, posters or newsletters can be utilised to highlight the issue.

Contamination of water, soil or air on/around the premises should be immediately escalated to the appropriate authorities and safe alternatives for the children put into place. Emergency procedures will be implemented as necessary.

The Centre will ensure that there is a Safety Data Sheet (SDS) folder for every chemical. This folder will be located near the chemical cupboard. All staff will be made aware of the location of the SDS folder and how to read a SDS.
